FIREARMS LICENSE APPLICATIONS PROCESSING TIMES

We can now confirm a significant increase in additional members of the firearms licensing department which consists of both police staff and officers. This has enabled the priorities of the department to concentrate on both grant and renewal applications.

We are currently progressing applications from the following dates:

Devon & Cornwall Police renewals - Feb 2022

Dorset Police renewals - Sep 2021

Devon & Cornwall Police grants - May 2020

Dorset Police grants - May 2020

There are some exceptions to this in each Force area.

Firearm variations are generally processed within 28 days however there will be exceptions where further enquiries are required by the Firearm Enquiry Officers.

STAKEHOLDER ENGAGEMENT AND COMMUNICATION

In November our teams have met with our partner organisations from the shooting communities to share learning, best practices and improve our service.

Our staff have also attended a dealership with Devon and Cornwall, where we were able to provide service and advice, at various levels, to attendees.

This type of engagement, and attendance at larger public events, is part of our communications strategy to enhance our visibility and provide our communities with an opportunity to make enquiries on a personal level.



HOW CAN YOU HELP US?

Please submit your renewal application in plenty of time, preferably 12 weeks prior to expiry or at least eight weeks (56 days) prior to your certificate expiry date. Failing to submit a renewal, on time, will result in further processing delays and a potential for you to have to store your guns with another authorised person.

If your application is received at least eight weeks prior to certificate expiry, and we are unable to process your application before expiry, you will receive an eight-week extension letter. This will enable you to continue to legally possess your firearms, shotguns or ammunition without the need to store them with an authorised person.

Ensure you download the GP proforma and ask your GP to complete the form. You must ensure your completed GP form has been forwarded to the firearms licensing department for processing. You will not be granted a certificate without the medical proforma being received and considered as part of your application.

Temporary permit (Section 7)

If you are issued with a Section 7 temporary permit you can continue to possess the firearms/shotguns/section 1 ammunition, held on certificate, without having to put them into storage with another authorised person.

A permit does not authorise the purchase or acquisition of new firearms or ammunition, however shotgun ammunition can be purchased if you have a temporary permit.

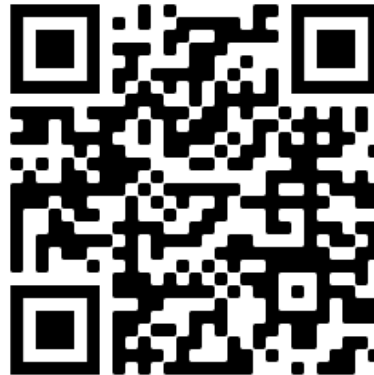


ONLINE APPLICATION SERVICES

National Firearms Licensing updates

Please note that with effect from 9 November 2022

An update of the non-statutory firearms guidance has been published on gov.uk

The amendments to the guidance are as follows:

- Paragraphs 6.37 and 12.67 – guidance on UK Athletics licensed race starters.
- Paragraph 7.10 – re-inserted guidance on the exemption under section 11(6) relating to organised clay pigeon shoots; and,
- Paragraphs 15.27 and 15.28 – new guidance on ‘remote’ sales by registered firearms dealers.
